**ARTICLES OF INCORPORATION
OF
BI TECH SOLUTIONS INC.**

The undersigned, pursuant to Chapter 9 of Title 13.1 of the Code of Virginia, states as follows:

1. The name of the corporation is BI TECH SOLUTIONS Inc.
2. The purpose for which the corporation is formed is to engage in any lawful business not required to be specifically set forth in these Articles for which a corporation may be incorporated under the Virginia Stock Corporation Act.
3. The corporation is authorized to issue 25,000 shares of common stock.
4. The name of the corporation's initial registered agent is Tauseef Khan. The initial registered agent is an individual who is a resident of Virginia and an initial director of the corporation.
