

**ARTICLES OF ORGANIZATION
OF
SOLIDEN TECHNOLOGIES LLC**

The undersigned, pursuant to Chapter 12 of Title 13.1 of the Code of Virginia, states as follows:

1. The name of the limited liability company is Soliden Technologies LLC.
2. The purpose for which the limited liability company is formed is to engage in any lawful business, purpose or activity for which a limited liability company may be formed under the Virginia Limited Liability Company Act.
3. The name of the limited liability company's initial registered agent is Dean Henderson. The initial registered agent is an individual who is a resident of Virginia and a member or manager of the limited liability company.
