

**ARTICLES OF INCORPORATION
OF
LEBAL DROCER, INC.**

The undersigned, pursuant to Chapter 9 of Title 13.1 of the Code of Virginia, states as follows:

1. The name of the corporation is Lebal Drocer, Inc.
2. The purpose for which the corporation is formed is to engage in any lawful business not required to be specifically set forth in these Articles for which a corporation may be incorporated under the Virginia Stock Corporation Act.
3. The corporation is authorized to issue 33 shares of common stock.
4. The name of the corporation's initial registered agent is James Kenneth Galloway. The initial registered agent is an individual who is a resident of Virginia and an initial director of the corporation.
5. The address of the corporation's initial registered office, which is identical to the business office of the initial registered agent, is 1111 Grove Avenue, Apt. 1, Richmond, VA 23220. The initial registered office is located in Richmond City, Virginia.
